The Senior Pastor is expected to provide spiritual instruction and strategic leadership to the members, staff and ministries of the church. In addition, the Senior Pastor is also expected to have administrative and organizational skills along with expertise in Christian Education. The Senior Pastor must be able to relate and connect with multiple generations, to provide Pastoral Care to the church and outreach to the community. The applicant must be a visionary for church growth. Lastly, the Senior Pastor will be expected to extend God's grace to others and lead by example as one who is relational, authentic, transparent, and humble.

Responsibilities: Use the standard required in I **Timothy 3:1-7; Titus 1:5-9; I Peter 5:1-4** as a guide for personal behavior.

Worship: Conduct worship that enables people to hear the Word of God and encourages participation in personal and corporate devotion resulting in a stronger relationship with God. Prepare and deliver sermons at all regular worship services of the church. Prepare and lead all special events of the church

Spiritual Growth: Guide the spiritual transformation of the congregation through teaching, preaching, and leadership by example. Work with the Staff to ensure that the church is provided with opportunities to pray and to study the Bible. Ensure that the church is provided with opportunities to be involved in service within and beyond the church. Encourage the congregation to give time, talents, and resources in service to God.

Administration: Oversee all areas of the congregation's ministry in consultation with the Deacons, Church Officers, and Ministry Leaders. Support, supervise, manage and provide input for the evaluation of Church Employees in conjunction with the Deacons and the Trustee Board. Ensure collaboration among Church Staff and Ministry Leaders. Facilitate and attend regular meetings to coordinate the ministries of the church. Enable Deacons, Church Officers, and Ministry Leaders to better perform their duties through training and support. Work with the Trustee Board to see that the facilities of the church are functional and in good repair.

Outreach: Have a heart for the Second Baptist Church ministries and an understanding of the challenges of sharing the gospel in the community. Make a concerted effort to engage new members and encourage them to take an active role in the church. Provide training opportunities to the congregation for outreach and evangelism. Support various mission opportunities and increase participation in personal mission service.

Pastoral Care: Visit or contact church members to encourage their involvement or to address their personal needs (especially all sick and shut-in church members). Provide pastoral care in conjunction with other Ministers, and Deacons through visitation, and prayer.

Professional Qualifications: Ordained Baptist Minister with a Master's Degree or higher from an accredited seminary or divinity school. Minimum of 5 years of pastoral experience serving in a large (400+) congregation.

- Official (sealed) transcript from postsecondary institutions
- Proof of Ordination as a Baptist Minister, licenses and all other certificates noted in the resume
- Please provide three references one Pastor, one Layperson, one Personal (References provided will only be contacted should you make it to the semi-final round)
- Link to a sermon delivered within the last two months
