A Pastoral Search Committee representing the membership of Aenon Missionary Baptist Church in Rochester, New York is seeking to fill the full time position of Pastor to lead its congregation. The Search Committee prayerfully seeks the wisdom of God and holds firm to Jeremiah 3:15; "And I will give you pastors according to mine heart, which shall feed you with knowledge and understanding."

Our new Pastor must be responsible for the biblical and spiritual obligations unto God as outlined in 1 Timothy 3:1-7 and Titus 1:5-9 and to the body of believers of this ministry. Therefore, a candidate must be a man after God's own heart (1 Samuel 13:14).

The Pastor serves as the chief under-shepherd and overseer for God's Holy Temple, providing spiritual instruction and strategic leadership to members, staff, and officers of Aenon Missionary Baptist Church.

- 1. A licensed and ordained Minister of the gospel of Jesus Christ.
- 2. A caring and compassionate leader with a true love for God and God's people.
- 3. A mature leader with strong moral character, spiritual, and personal integrity as demonstrated daily with faith, trust, and obedience to the Word of God.
- 4. Leads the congregation in Sunday Morning Worship and instruction of the Word of God at the church and elsewhere. Demonstrates leadership for the church in both spiritual and financial growth.
- 5. Leads the Church in the importance of prayer in our daily lives.
- 6. Works closely with the Board of Deacons, Board of Trustees, and ministries to carry out the vision of the church.
- 7. Visits the sick and shut-ins providing spiritual guidance and encouragement.
- 8. Serves as moderator of quarterly Church business meetings.
- 9. Conducts counseling sessions, performs wedding ceremonies, and funeral services.
- 10. Leads and demonstrates strategies that witness to lost souls leading them to Jesus Christ.
- 11. Is affiliated with and actively participates in local, associational, state, national, and denominational sessions helping to promote important matters of the church.
