**Chaplain Diane Peterson** – Dianne is Executive Director of Alaska Police & Fire Chaplains Ministry and the Commander for Alaska with Chaplain Fellowship Ministries. Diane is board certified in Clinical Chaplaincy and Pastoral Counseling through the College of Pastoral Supervision and Psychotherapy (CPSP). Diane has extensive training in CISM, Crisis Negotiation and suicide prevention and post-vention. In 2016 Chaplain Peterson received the Presidential Call to Service Lifetime Achievement Award.

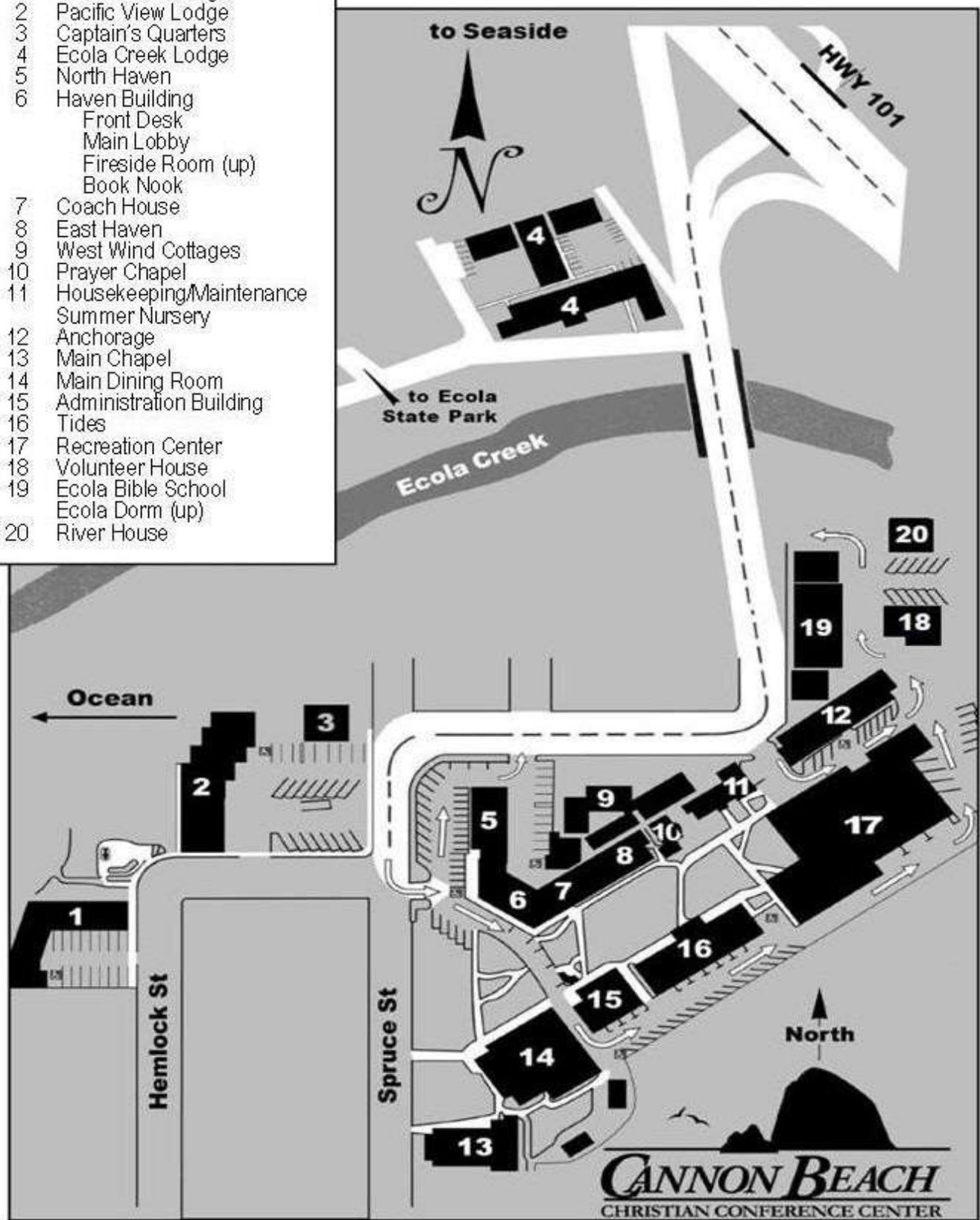
