# NORTHMINSTER PRESBYTERIAN CHURCH STATED SESSION MEETING August 16, 2017

Bob Silver made a motion which was properly seconded to approve the agenda. The motion passed.

# 1. Membership - Valerie Wilde

- a. On July 9, 16 and the 23<sup>rd</sup> Pastor Wally held an Inquirers Class for potential new members and anyone interested in learning more about our Presbyterian Faith. b. On July 30<sup>th</sup> we welcomed five new members to our church family, 4 by Transfer of Membership and 1 by Reaffirmation of Faith. To date we have received 20 new members in 2017.

- d. Our Shepherd's Program in matching new members with current members of similar interests is still working well.
- e. We are excited and looking forward to the future in welcoming new members under Pastor Wally's leadership.

# 2. Worship – Sanford Mullet

- a. Wheelchairs and walkers shall be stored to ensure the church aisles are not obstructed during the service. Ushers shall store these items after seating the individual, and return appropriate item to its owner at end of the service.
- b. Marlys Miinch assisted Diane Price prepare communion elements for August communion August 13. These was sufficient communion bread for this service.
- c. Marlys Miinch will prepare the bread for September communion. We shall advertise for church volunteers to serve by making this bread. Diane Price has the recipe for this task.
- d. Bob Olson has resumed candle maintenance and lighting duties.

Larry Brown made a motion, which was properly seconded, to approve the Treasurer's Report. The motion passed and the full report filed for audit.

#### B. Finance Committee Report – Jack Tibbets and Tom Latimer

- 1. Mortgage In keeping with our new procedure, we are sweeping the funds in our PILP Building Fund money market account which are over our reserve of one year's monthly minimum payment (currently \$31,800) and applying the money to the mortgage principal. During July we paid off an additional \$7,400. During August with the receipt of several large annual donations we plan to further reduce the principal by \$20,000 to a total of approximately \$340,000.
- 2. <u>Future Physical Plant Maintenance Requirements</u> A listing of significant upcoming expenses has been prepared and methods of funding are being discussed. The Finance committee will provide details on suggested plans this fall.

3. <u>Cornerstone Fund</u> A plan to reintroduce the Cornerstone Fund is being implemented. A message will be in the September *Good Tidings*, an announcement will be made during Worship on September 24 and a package will be mailed to each member and friend in October.

Sanford Mullet made a motion which was properly seconded to approve the Finance Committee report. The motion passed.

# C. Clerk of Session Report – Sally Kirby

Bob Silver made a motion, which was properly seconded, to remove from our Active Rolls Lois Anderson, Trudy Gremp, Nancy Mullet and Velma Otten who have gone to the church triumphant. The motion passed.

## D. Property Report - Larry Brown

Tom Latimer made a motion which was properly seconded to approve the Property Report. The motion passed.

## E. Outreach and Marketing - Ron Myers

- 1. NPC attendance is increasing at approximately a rate of 10 percent from 2016.
- 2. The Bible study mailer has been prepared which includes a brief description as well as dates and times. Dick Murphy and Pastor Wally will determine the front cover.
- 3. The information mailers for Bible study will be mailed at the end of August, and the mailers to the 600 new residents will be mailed at a later date. The cost for both mailers is estimated between \$300-\$400.
- 4. The mobile home newsletter advertisement will be placed in four (4) mobile home parks for six (6) months and in the Meadows newspaper for four (4) months.
- 5. After discussion, the Angel Tree and the Day 4 Hope projects will be referred to the Missions Committee. Also, the Gospel Trio was referred to Ed Stiles.
- 6. Information regarding an electronic sign was presented by Jack. The sign would meet all zoning ordinances and cost \$17,500 -\$18,000. The Committee voted unanimously to recommend to the Session to move forward with pursuing the purchase and financing options for the electronic sign. This would normally be a function of the Finance Committee.

Bob Price made a motion that was properly seconded that we move forward with pursuing the purchase and financing options for the electronic sign with the understanding that the sign would not be purchased until the necessary funds were accomplished. The motion passed.

- 7. Life Touch has offered to provide a choice of either brochures, note cards, or postcards for an error they made. The Committee chose the free note cards.
- 8. Pastor Wally has prepared information cards to replace the current information brochure. A free standing rack will be built with extra space for special event cards.

Bob Silver made a motion which was properly seconded to approve the Outreach & Marketing Committee Report. The motion passed.

### VII. OLD BUSINESS:

- A. Pastor Wally's Trip to Cuba October 5-10, 2017 The trip is a go, flying into and out of Havana. Flights are made and permissions secured. Will need pulpit supply for October 8, 2017. One of the hopeful outcomes is that partnerships develop with sister churches in Cuba.
- B. Update on Search Team Pastor Wally: The task force is Ed Stiles, Dick McGuire, Jim Stoltie, Sylvia Eckes, Sally Kirby and Pastor Wally. Interviews start August 17. We have 6 interviews set up at this time and another possible interview. First round interviews will be verbal interviews and then a second round that will involve and audition. The committee is looking for the "fit". The committee is committed to not making a quick hire, but a correct hire. An interim musician may fill in for September and October. A gift for Jay was discussed, perhaps a month of vacation pay that he never took in addition to a tangible gift.

Bob Silver made a motion that was properly seconded to give Jay a month vacation pay and also give him a gift of monetary value of \$500. Dick McGuire will purchase the additional gift. The motion passed.

C. 2017 Presbytery Gathering – September 13, 2017, 9:00 A.M. to Noon, First Presbyterian Church, Port Charlotte, Florida. Session members were encouraged to attend.

### VIII. <u>NEW BUSINESS</u>:

A. Bob Price made a motion, which was properly seconded, to elect Sally Kirby and Sanford Mullet as Elder Commissioners to represent Northminster at Peace River Presbytery Meetings and Jack Tibbets as Alternate for the rest of 2017. The motion passed.

	software program. The advantages are that the cost is a little less, it's a cloud-based
	system and the system allows us to increase our functionality. The conversion of
	the data has been accomplished. Membership and Deacons will be helped the most.
