- a, The attendance for the first 26 weeks of 2018 averages 156 compared to 178 in 2017. Sally stated that the Membership Committee analyzed the decline and attributed the decline to health reasons of the membership.
- b. The New Movers Program mailed 109 cards during June. The follow up letter is being sent the last week of the following month.
