2099B ~ PRINCIPLES AND PROCEDURES FOR DEANS OF CHRISTIAN EDUCATION –Textbook: 2016 Revised CLS Manual

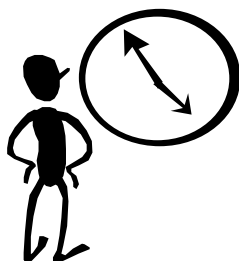
Review the step-by-step procedures for accrediting Christian leadership schools. Beginning with Step 1 (selecting and certifying a dean) and continuing through Step 13 (completing and submitting the final report), together with the dean's annual report to the state director. The concept of dean of record will be introduced to the student, along with a clear explanation of the certificate and specialization programs.

2099C - PRINCIPLES AND PROCEDURES FOR DEANS OF CHRISTIAN EDUCATION – Textbook: 2016 Revised CLS Manual

Lead a review of forms and administrative procedures. The students will be alerted to “hot spots” to be avoided by deans and presidents in the planning and supervision of the school as it progresses. Likewise, the students will learn steps for advising and monitoring individual students through the phases and programs of the Christian leadership school system.

2099D - PRINCIPLES AND PROCEDURES FOR DEANS OF CHRISTIAN EDUCATION – Textbook: CLS Manual

Prepare the students for internship and the administration of their first school, and for advising and guiding individual students through CLS programs. Students will review the entire program of instruction. Emphasis will be placed on the enhancement of Christian education in all areas: COPP, Sunday school, Bible study programs. Training Union, and other teaching venues. The students will explore ways in which unity can be developed throughout the conventions education ministry at the local, district, state and national levels.
