



iPAD ACCEPTABLE USE POLICY

1. Students must abide by all school rules as outlined in the Student/Parent Handbook and Acceptable Use Policies of La Purísima Concepción Catholic School, the Archdiocese of Los Angeles, and the Department of Catholic Schools.
2. iPads are for educational use. Students who play games, text, or attempt to access any social networks during class time will have their iPads returned to the cart/storage box for the remainder of class. Repeated violations may result in loss of iPad privileges.
3. All students are assigned an iPad for the duration of the school year. Students agree to be responsible for the proper care of the iPad and follow directions of the teacher(s) during class. Parents will be held financially responsible if damage occurs to the student's iPad because of inappropriate use during class.
4. Students and Parents agree that any inappropriate use of the iPad will result in school discipline that may include the loss of iPad use. Disciplinary action includes but is not limited to detention, conduct referral/reflection, suspension/expulsion according to the Parent/Student Handbook. Inappropriate use includes but is not limited to the following:
 - a. Visiting inappropriate websites,
 - b. Bypassing (or attempting to bypass) the La Purísima Concepción Catholic School web filter through a web proxy,
 - c. Changing iPad settings (except for personal settings such as font size, brightness)
 - d. Downloading apps or any media,
 - e. Attempting to "jailbreak" the iPad (that is, attempting to alter the iPad's operation system in order to run additional, unauthorized applications),
 - f. Gaining access to other students' accounts, files, and/or data,
 - g. Sending, accessing, uploading, downloading, or distributing materials that are offensive, threatening, profane, obscene, or not school appropriate,
 - h. Using or advocating racial, ethnic, religious, or gender-based slurs,
 - i. Using technology to threaten, bully, or harass others,
 - j. Using chat rooms or any social network environment not approved or managed by La Purísima Concepción Catholic School,
 - k. Illegal installation or transmission of copyrighted materials.
5. Students and Parents acknowledge that La Purísima Concepción Catholic School may review the contents of school-issued iPads (or iPads designated for school use) at any time to verify content. Students may not set a privacy code on their iPads. Consequences and violations

could include but are not limited to revocation of internet access, network privileges, computer access, detention, suspension, or expulsion. Records of Digital Citizenship and Responsibility will become part of the student's file and will be included with his/her transcript/application as part of the high school application process.

6. Students and Parents acknowledge that La Purísima Concepción Catholic School can and will manage iPads remotely through an online device management system, as well as a content filtering system. This system gives the school the ability to restrict or remove applications from the iPad, to view applications installed on the iPad, as well as the ability to remotely lock or erase the device and its data.
