Treasurers Report

January 29, 2017

We are experiencing challenging times in Williston with the downturn in the oil industry. But the one thing I found in my first year as treasurer is that Gloria Dei parishioners are generous and giving especially when they know there is a need. This year the Stewardship Committee started the "Above and Beyond" to solicit funds for items that were not included in the budget. All of the needed items were funded within a short period of time. Thank you for your generous donations to meet these needs.

There is a decline in GDLC oil revenue in 2016 from previous years. Our oil revenue in 2016 was \$34,093.50 compared to \$49,112.60 in 2015. Oil revenue is deposited into the Building Fund which is used for major building repairs. The GDLC Council's goal is to maintain a balance of \$90,000 - \$100,000 in this fund. The balance in the Building Fund as of December 31, 2016 is \$112,832.81.

The 50/50 Debt Retirement Fund is the account used to pay our Thrivent Mortgage payment of \$6552 monthly. The balance of the mortgage as of December 31, 2016 is \$255,271.09. The GDLC Council's goal is to maintain a balance of \$60,000 in the 50/50 fund which is nine months of mortgage payments. The balance in the 50/50 Debt Retirement Fund has not been sufficient to continue to pay the additional \$1000 monthly on the Thrivent Mortgage so the additional payment was eliminated in June 2016. The balance in the 50/50 Fund as of December 31, 2016 is \$(6157.86) so additional donations are needed to bring this fund back to the desired \$60,000 balance and pay the additional \$1000 on the mortgage payment to reduce the principal.

GDLC is seeking a second pastor with an emphasis on youth. This is important to the growth of GDLC. The additional pastor position will require additional financial support from the congregation. Please prayerfully consider your donation to help fund this position in 2017.

Thank you for your financial support in 2016. There are exciting opportunities for GDLC in 2017 so thank you in advance for your continued support.



In addition, in the spring, it is likely there will be only 3-5 more new Seminary candidates. I pose this question, what should we do to fill this void as we wait for God's direction? Should we seek an interim pastor or explore other ways to provide Pulpit Supply? Should we renew the Stephen's Ministry Program? Any other ideas?

Lastly, I also must confess a failure on my part. I had sincerely hoped to encourage special music for each service during the year. I truly miss this and I think if we are able to get people to step up, it encourages a sense of belonging and contributing to our church. If any of you have any thoughts for this, please let me, the Worship Committee or the office know.

Even though we do have challenges ahead, I want to again assure all that God has surely blessed Gloria Dei Lutheran Church. Let us together, Gather to Grow to the Glory of God! Blessings,

Continual change seems to be the best way to describe Williston. When the ministry began the fall of 2014 Williston was at the end of the "boom." There were buildings and roads going up everywhere. New people were still arriving everyday hoping to find instant employment. Then in 2015 the oil prices took a tumble and new exploration slowed down. Many people got laid off or were sent to other oil fields. Others chose to go "home." As savings and unemployment ran out people that stayed were unable to pay their monthly bills. Jobs are still plentiful however, the rate of pay is about half of what it was during the "boom."

Building relationships with churches and social service agencies is at the center of what we do. We work hard to be the trusted place to go for information about how to care for people in our community. Over the summer of 2016 eight churches in the Williston area experienced a change in their clergy leadership and several other key leaders including Chamber of Commerce, Downtowners Association, Williston State College, Williston School District #1 and Bakken Elementary all experienced transitions. We hosted an event called Keeping Williston Connected in September. Social service agencies were invited to give short presentations to familiarize the new leaders with services available in Williston. New clergy, education leaders and community leaders were all invited to attend along with employers that were attending a Job Service ND Job Fair in conjunction with Keeping Williston Connected. More than 50 people attended.

2017 promises to be even busier:

• Churches in Williston now use Community Connections as their screening and referral service. They require that people come to meet with us prior to coming to see them.

• Starting January 1 people that had been going to First Lutheran for assistance will now go to Community Connections for that assistance. Faith United Methodist is also moving to have their assistance be administered by us. Gloria Dei Lutheran will retain their food shelf but is considering becoming a mission partner in the ministry.

• Community Connections is the area coordinator for the ND Coalition for Homeless People. We will be working with the Williston Resource Group to coordinate the Point In Time Count held every year to count the number of homeless people living in the area. We plan to use the information to give 10-12 presentations in the Williston area in 2017.

• We are currently putting together an even't team to plan a fundraising event for Community Connections. We have to held the growt in the full of page.

tions. We hope to hold the event in the fall of 2017.

• The Advisory Board of Community Connections has asked us to work on three goals in 2017:

Provide more follow-up for clients and donors.

O Continue to build more relationships with churches and donors.

O Look at restructuring the board to include church partners and formalize the structure of the board.

As we look forward to 2017 we find our strength and comfort in the words from Hebrews, "Jesus Christ is the same yesterday, today and forever." We are excited and humbled to be serving as disciples of Christ through Community Connections.
