

PRESIDENT'S MESSAGE

Mike Hardgrove,
President of the International
Conference of Police Chaplains

I would like to share with you my comments after being sworn in as your President at the 40th Annual Training Seminar banquet. I take very seriously the trust you have placed in me for the continuation and growth of our organization.

Thank you for allowing me to be your President and for the honor of serving with the fine people you elected today to work as your Executive Committee. I take on the responsibilities of this position with humility and a deep desire to continue the ICPC tradition of providing the best training possible for the men and women who give their time, their talents and their hearts in service to the men and women of law enforcement; for this organization truly exists for them and not for us. Therefore, our number one priority is taking care of our law enforcement officers. Everything else is secondary.

To be efficient and effective in our service we must focus on **COMMUNICATION** and **TRAINING!** To care for those who are crisis responders we must also be able to react swiftly to their needs. How then shall we improve our communication and training? We start first at our main line of communication, our web page.

I am working with Hillman Design of Sedona, Arizona who will be working with our website company to install a Forum on our Members Only section of the website. For those of us who have been a part of ICPC for many years it is easy to pick up the phone or shoot off an email to a friend asking for advice. A new chaplain most often will not be able to do that. With a Forum

they will be able to post a question and get quick replies from our experienced and time-tested chaplains. This will eliminate some frustration in the new chaplain's life.

I am also in negotiations with WebEx to build both an Internet Meeting Center and an Internet Training Center. The meeting center will allow us to have Committee meetings, Executive Committee meetings and Board meetings, as often as the need arises rather than waiting a year for the Annual Training Seminar. The training center will allow all new chaplains to access the 12 Core Courses as soon as they would like or as they are needed. If WebEx cannot meet our needs within a reasonable budget we will find another provider.

With internal communications I will be asking our Executive

Committee, our Standing Committees, our Regional Directors and our Area Representatives to either have regular meetings or be in touch with the Chaplains they serve monthly via an email string or newsletter.

We will also be posting new videos on our website to showcase our ICPC office, our Committees, and partner organizations and the work they do. It is our hope that these videos will help members be prepared to answer when we ask; "Where would you like to serve?" or "Where is God calling you to minister?"

If you have gifts and graces that will help us accomplish our communication changes and would like to be a part of it, please notify me or Ruby Kinlaw, ICPC Executive Administrator as soon as possible.

I have also begun working with the Credential Committee and Academic Registrar to see if we can manage our credential process so that when you have completed the requirements for a credential and your application has been approved you may receive that credential and not have to wait for the next ATS. You will still be recognized at the ATS for your accomplishment but you won't have to wait until the ATS to receive the credential. Rick Kassel, Credential Chair and John Transue, Academic Registrar are both in favor of working toward that end. Of course there are always details that need to be looked at and procedures that will need to be changed. I have also recognized two other

priorities for ICPC. The first, is that we must search out, recruit and train younger leadership for our organization. We must identify chaplains who are dedicated to our continued quest to provide the best training and support possible to law enforcement chaplains so that our law enforcement officers don't have to ever feel alone, forgotten and cast off because of the stresses of their profession. These chaplains must not be satisfied with the status quo.

The second, is that we must continue searching out and establishing relationships with other like-minded organizations. There is no room for exclusivity in our ministry. We must be in relationship to share and to receive. We cannot re-invent the wheel every time we see a need.

In preparing for closing I asked that all military personnel, past and present, stand and be recognized as our first line of defense from evil and chaos. I stated that these are the men and women who have pledged to give all they have for us; even their lives

I then asked for all Law Enforcement Officers, past and present, to stand and be recognized as our second line of defense and the people who have pledged to serve and protect the citizens within the borders of our lands. I stated that they too, have pledged to give all they have for us; even their lives.

Next I asked all Chaplains to stand and be recognized. When life gets heavy and decisions become hard to make, I stated, our Military Personnel, our Law Enforcement Officers and our Emergency Services

Officers come to you, their chaplains, for wisdom, comfort and hope. I asked all chaplains present: Can we do no less than attempt to be the best we can be for them? Are we willing to give all we have for them, even our lives?

The last people I asked to stand were all family members and close friends of our Military Personnel, our Law Enforcement Officers and our Chaplains. To them I said: You are the bedrock, the support, the encouragement, the acceptance and the love that makes our service possible. When all else fails our thoughts of you give us strength to carry on. May God bless you even more abundantly than you bless us.

We are a team. We are one. We do not, and cannot, operate on our own. We need each other. We depend on each other.


Please turn and thank the people around you for what they mean to you and for the gifts they give to you each day.

Article I Section 5

The Board of Directors, Executive Committee, Standing Committees and Special Committees shall be authorized to meet by telephone conference or through other electronic communications media, as long as all members may simultaneously hear each other or be recognized and participate during the meeting. An e-mail thread shall be secured by the Secretary or in the event of telephone conference or on-line meeting sites, a complete transcript shall be retained in the minutes of the organizational unit.

Article I Section 6

Unless otherwise provided in the Certificate of Incorporation, these Bylaws, or the Not-for-Profit Corporation Law of the State of New Mexico, any action required or permitted to be taken by any board or committee of any organizational unit of the ICPC, including electronic voting, may be taken without a face to face meeting.

CREDENTIAL UPDATES—2013

Effective immediately a credential must be held sequentially prior to application for the next level (e.g. must hold Basic to apply for Senior, etc.). Additionally, all application requirements must be met prior to submission.

Master applications received **before** November 30, 2013 may choose Track A (25 CEU and paper) or B (35 CEU) and upon ap-

proval will be awarded at the 2014 ATS.

Effective **December 1, 2013:**

- Application for Basic, Liaison, Senior and Master will not have a submission deadline. Certificate will be awarded upon approval of the Credential Committee.
- Master Level will require **35**

CEUS (no paper submissions allowed and must have held Basic and Senior Level Credentials prior to application).

Diplomate and Fellow deadline submission will be **March 30** and upon completion and approval of the Credential Committee will be presented at the next ATS.

ICPC—Reflecting on 40 Years Chaplain Charlie Massey

Editors Note: This is part three of a series of articles reflecting on ICPC's 40 year history.

WE HAVE COME A LONG, LONG WAY

WOW!!! Have we ever come a long way. We are 40 years old. Where have those 40 years gone? I find it hard to believe that the International Conference of Police Chaplains has been around, doing wonderful things for so long.

Although I am not one of the charter members of the organization, I have been a member from the beginning. As I think about this, a lot of great memories come flooding back to me, particularly the people. I remember Joe Dooley talking about his dream of a chaplains' network. I remember the early folks, many of whom have gone on to their eternal reward. I remember such folk as Joe Dooley, Joe Coleman, Wilber Harvey, Virgil Bonto, Jack Price, Gerry Brinniger, Bill Travers, Julius Kirchgessner, Donald Rogers, David Gensler, Gerry Priest, and of course the ever present Bill Wentink who is still very much a major part of the organization.

Continue to dream, to serve, to be involved, to care
and not to count the cost. The International
Conference of Police Chaplains is only as strong and
healthy as its membership.

I remember in 1975 taking an overly tremendous amount of time at the business meeting discussing a budget of less than three thousand dollars... and now we pass a budget of almost half a million in several minutes. I well remember the ATS in 1976 when we took our first steps on our own without the parent body which had spawned us being in the picture.

I remember being elected 2nd vice president in Nassau County, NY in 1978, becoming the first president from beyond the United States border in 1981.

I remember meeting in Washington, DC, in the late 70's with Bob Cornelius and Gerry Brinniger to draft the first Chaplains' handbook of guidelines. That was replaced in 1989 by CHAPLAINCY IN LAW ENFORCEMENT. What it is and how to do it, published by Charles C. Thomas.

Spotlight on Chaplaincy

In addition to caring for their own flocks, two local ministers tend to a flock on the side. Its members wear blue.

The Rev. Mark Broadhead, pastor of the Laurel Hill and Crestview Presbyterian churches, established the Crestview Police Department's volunteer chaplains program in 2008.

Broadhead built the Crestview program as an informal chaplaincy headed by a former officer, Sgt. Dave Bracewell, a local pastor and the then-Crestview SWAT team sniper.



Joining Broadhead as the second police chaplain is the Rev. Paul Mixon, pastor of Out of This World Ministries in Crestview. Both have credentials through the International Conference of Police Chaplains.

Chaplain Training

"Training is needed by non-law enforcement chaplains to under-

stand how to respond to the officers, to be an asset to them, and not be a liability," Broadhead said.

Prospective chaplains must complete 12 basic courses with a minimum of 35 classroom hours to reach the first level of credentialing, Broadhead said.

He has an additional 36 hours of training in critical incident stress management, which prepares chaplains and emergency responders for major traumas such as line-of-duty death, a mass shooting or a community-wide catastrophe.

It is a service that is valuable to those we serve, appreciated by those we serve and extremely rewarding to those who serve.

The Step That Changed His Life

Chaplain Mike Meyer used his cane to steady himself as he knelt at the altar at the Central Florida District Assembly to be ordained elder in the Church of the Nazarene. As he maneuvered his prosthetic legs into a kneeling position, he remembered how one step in Vietnam changed his life forever. Forty years--and it was still picture-clear in his mind.

It was September 26, 1971. Mike began the second humid day of a mission to locate and explode armed charges in a known minefield. He had volunteered for duty in Vietnam. Anything was better

for this Floridian than the biting cold he had endured in Germany, or so he thought.

If a land mine couldn't stop him, nothing will. His life is a walking object lesson for this truth, step by obedient step.

Michael had just placed a charge next to a cluster of "bouncing Bettys," baited traps that didn't detonate until someone stepped off of them. They shot a person about three feet into the air, exploding

with metal balls that could cut a soldier in half.

In a mind-stopping moment, an invisible force picked Mike up and placed him in a pinball explosion of shrapnel before dropping him hard to earth. Feeling fortunate because he had no pain, he tried to figure out how he could have taken a mine blast without injury. That's when he saw what was missing—his right foot. He also saw that the spray of shrapnel had reduced both legs to pegboards. The blast should have killed him.

diaries among the police, residents and support agencies such as the Trauma Intervention Program.

"And I listen to venting," Broadhead said. "But there's not so much anymore, though."

However, following last year's dismissal of former Chief Brian Mitchell and one of his majors, Broadhead said there was "lots of venting."

Keeping Cops Strong

"It's a neutral area within the department," police spokesperson Lt. Andrew Schneider said. "If you have problems, you don't want to talk to your boss about or family issues — anything that might interfere with your work — that's why we have this program.

"We have to stay strong while we're on call, but we're human, too. We have emotions too, and (often), these things build up. We

have to have somebody we can talk to."

Crestview's police chaplains provide marriage counseling, personal counseling and suicide prevention intervention for officers.

"Training is needed by non-law enforcement chaplains to understand how to respond to the officers, to be an asset to them, and not be a liability.

Joys and Rewards

During a spring seminar called "Help! I Love a Cop!" officers and spouses discussed the transition between finishing a shift and returning home. The transition can be stressful for both officers and their families, Broadhead said.

"On a call, the officer has to cut through the drama and get to the facts," Broadhead said. "At home,

The next year was an endless parade of infections, surgeries, hospitals, pain, double amputation above the knees, medication, rehabilitation, and prosthetics—all because of one wrong step. But God had other steps for Mike, steps he could take without his legs, steps that would give him life and purpose.

When he received medical retirement in 1972, Mike returned to school to earn a GED. Frustrated with wheelchair life, he started using Canadian crutches, the kind that offer forearm support from a metal cuff. Then, he graduated to cane-only assistance, a feat that doctors told him would be next to impossible. Using military benefits, he continued on to college, graduating from Florida Atlantic University. In 1982, he married Barbara Jean. Step by step, life continued to open for Mike.

Then, there was another explosion. Barbara was diagnosed with stage III ovarian cancer. While cancer changed everything, it also led them to take the most important step of their lives. In the days of fatigue following chemotherapy, Barbara had started watching a TV evangelist. She urged Mike to watch, too. Wanting to do anything to help his wife, Mike suggested they visit an Orlando church. This was an unusual step for both of them. Mike had been

raised nominal Catholic and Barbara had embraced Christian Science.

God spoke to Mike and Barbara the night they visited the church. Both went forward to repent and receive new life through Christ. Mike remembers, "A strange sensation came over me. I felt like I was walking about a foot above the floor. The Lord removed so much that I felt like I was a helium balloon."

Their search for a nearby church led them to the Davie Westside Nazarene Church. They found a group of people who loved them through the difficult days to come. They stood by Mike when Barbara lost her six-year cancer struggle in 2001.

As Mike adjusted to his single life, he heard God speak again. "I believe the Lord has put a call on my life," he told his pastor. It was not the first time he had thought about ministry. When he was 16, he dreamed the same dream three nights—he was a priest saying mass in a Catholic church, except

no one in the church was Catholic.

He had started paperwork to become a priest while hospitalized after amputation, but felt checked not to complete the process. Now he understood that he was right about ministry and wrong about the priesthood. When he found out that Asbury Theological Seminary had an Orlando campus, he enrolled.

God brought another wonderful woman into his life and they married in 2005. Bertha became a positive supporter during his arduous studies at the Central Florida Nazarene Bible Institute and Asbury Seminary in Orlando.

One night while Mike watched a story about police chaplains, he felt a tug on his heart. "I wonder if I could do that?" He called to find out the requirements and discovered that the new Orlando police chief planned to expand the chaplaincy program. By 2007 Mike became part of that expansion. Every crisis call confirms he's where God wants him. Like the middle-of-the-night call he received to console two teenaged boys who witnessed the fatal shooting of their mother and grandmother at the hand of their father.

As Mike Meyer, police chaplain,

Geneva Silvernail, former Nazarene missionary educator and now vice president for Asbury’s Florida campus, has seen Mike’s tenacity firsthand. “Michael is determined to answer a call regardless of his difficulties. It is appar-

ent that what he learns in class, he applies directly to his work.”

“It’s all God!” says Meyer. If a land mine couldn’t stop him, nothing will. His life is a walking object lesson for this truth, step by obedient step.

"It's a very rewarding privilege to be able to give something back to these fine officers," said Broadhead said.



