## Pastor's Message

On occasion, I cross paths with a social media post making the point that a person doesn't need to go to church to be a Christian. For the record, this is not only a tired statement but also a theologically lazy one. The simple Biblical fact is that Christians go to church. God mandates such fellowship. If you disagree, that is, if the Jesus you confess teaches it's okay to be apart from Him and the gifts He gives in holy worship, then you're following a false Christ.

I could go further with this, but I don't want to. As I said, it's a tired and lazy position. There's bunch of Bible verses that refute this claim that you don't have to go to church as a Christian. But I give you something that goes a lot further into the Christian life than worship attendance.

James 1:22-25 "Be doers of the word, and not hearers only, deceiving yourselves. For if anyone is a hearer of the word and not a doer, he is like a man who looks intently at his natural face in a mirror. For he looks at himself and goes away and at once forgets what he was like. But the one who looks into the perfect law, the law of liberty, and perseveres, being no hearer who forgets but a doer who acts, he will be blessed in his doing" (James 1:22-25).

Do you know what the "perfect law, the law of liberty" is? Just know that whatever it is, James is not only insisting that we persevere in it but that such determination is somehow born from hearing it and then results in living according to it.

Maybe the best way to figure out what James means is to begin with the words he uses, namely, the word he employs for "perfect." This word is equally translated as "complete." In other words, the completed law—the totally accomplished law—establishes a standard for freedom. Variations of the same word are used in other places throughout God's Word. But there is one crucial instance where it fully intersects with James' understanding of the Law. It happens in John 19:30. It's there the Lord announces from the cross a single word which is typically rendered as "It is finished." Although, it's just as accurately interpreted as "All is complete."

By "perfect law, the law of liberty," James has in mind Christ's absolute fulfillment (completion) of the Law on our behalf. By His work, we have been set free, not only from sin and death but from the Law's crushing burden as the only way of escaping eternal condemnation. In other words, instead of needing to keep the Law for salvation, which all of the apostles affirmed was impossible, we're free to live in and according to it. It becomes a law of liberty, not one of bondage.

James is saying that whoever keeps as one's heading the Gospel of salvation through faith in Jesus Christ—whoever believes and perseveres in it—will become a "doer," someone desiring to keep the Ten Commandments, not for salvation but out of love for Christ. These doers will do. And they will be blessed, not because they're performing the Law, but because they've been set free in Jesus.

# St. Paul Lutheran Church Quarterly Voter's Meeting Minutes March 19, 2023

(Covers period from Dec 11 to present.)

- 1. Meeting was called to order by Vice Chairman, Larry Cuklanz with 32 members in attendance.
- 2. Opening prayer led by Pastor Varns.
- 3. Minutes from December's meeting were reviewed. Motion made to approve by Jim Rigge, 2nd by Jim Wegner. Motion passed.
- 4. Financial/Designated reports from February were reviewed with no additions/corrections noted.
  - There was a question on our Thrivent dollars and what to use these for. Explanation by Anne that it is
    used for whatever we need to cover expenses as approved by Council.
  - Noted that insurance has increased. Insurance for others has risen also.
  - Questions raised on the West Entrance. This is for a vehicle drive up proposal and is on hold waiting for an estimate from Fagen's.
  - The front Brick Planter: Kerry Steffen had information from Don Hempel that there is about 40 bricks saved in the shed for the front planter so it can be repaired. Kerry will share this information with Avis Freitag and Paul Hinz who donated for this planter.
  - Men's Choir money is \$110 and there is no Men's Choir at present. Phyllis made a motion to move this money to the General Fund. Molly Hoff 2nd the motion. Motion carried.
  - Anne noted we exceeded the snow budget at this time. Hopefully, no more huge snowstorms! In the new budget next year, the snow removal will move from lay people to actual maintenance.

Motion made to approve the Financial/Designated reports by Mike and 2nd by Jayne. Motion passed.

## 5. Pastoral Report

- Regular activities Sunday morning worship service, recorded, edited, and uploaded; Sunday morning Bible Study, Monday morning 8:00 am men's Bible Study, Thursday morning 9:30 am women's Bible Study, Midweek and confirmation classes 5 pm to 8 pm, pastoral homebound visitations.
- Irregular activities: Christmas services and Lenten midweek services at 6 pm Wednesdays, funeral for Don Hempel.
- Confirmation this year has only one student, Dane Hildahl. He will be confirmed when he is ready
  due to some absences this month. This will be possible sometime this summer.

#### 6. Membership Report

Death: Donald Hempel died February 20, 2023 – funeral March 2, 2023.

### 7.1 Board of Elders

- Ash Wednesday Service February 22 was cancelled due to weather.
- Cancelled service on Sunday March 5 due to Pastor's illness.
- Last Tuesday's Council meeting, March 14 was cancelled due to another snowstorm.
- Midweek Lenten service at 6 pm
- Maundy Thursday April 6 at 7 pm, Good Friday Apr 7 at 7 pm, and Easter Sunday - Apr 9 at 9:30 am

### 7.2 Board of Trustees

- · Dishwasher drain is good.
- · Bathroom floor drains have been cleaned out.
- Exit light by kitchen entrance. Trustees will see if one is even needed, and Carol Gabbert mentioned there are glow-in-the dark signs available. This might be an option as the wiring for the light was used for the push button entrance.
- Dan E, Dennis S, Gene S, Travis L, & Pastor were acknowledged and thanked for all their work on the stripping and waxing of the floors in the back of the church, narthex, and Parish Hall.
- Jim W. said that the light bulb by the sidewalk needs replacing.

#### 7.3 Special committees

SAC – Nancy Cuklanz and Carol Podratz have agreed to take on the duties of setting up for funerals, finding workers, and ordering food. Request was made for people to step up for events coming up, such as Easter Breakfast rather than having one person responsible for SAC. A big thank you from the Council to the ladies working for Don Hempel's funeral.

#### 8. Old Business

- Registered voters Larry C. and Pastor have been approved for the Synodical voting for President. This is
  done every three years.
- Kerry S. commented on the landscape project for the courtyard. A new water meter will be needed, and that is an extra expense we are planning for. \$8,000 has been pledged but he would like to get another \$2,000. A plaque was mentioned for the courtyard for money given/memorials. This can be done for a part of it, such as benches, trees, but not for the whole project.

#### 9. New Business

- Election for open council positions: Vice Chairman, Elder, Trustee and Secretary. (These jobs according to Larry, do not take lots of time.) No nominations for Vice Chair. Elder Jim Rigge is going off and no candidate for this position so there will be only 5 Elders. Trustee Dan Enninga is going off. Tom Edman has volunteered for Trustee. Motion made to approve Tom was made by Dan E and 2nd by Dorothy Ims, motion approved. Secretary Mary will be continuing. If anyone is interested in any of the open positions, they can contact either Larry or Brad.
- Training for the new AED. The council will watch the DVD that came with the new AED at an upcoming meeting and then show it to those interested after church at fellowship.
- Jim Rigge made a motion to accept, 2nd by Jim Wegner, motion passed to make the yearly donation of \$600 to missionary Rev Jastram. This will come out of Thrivent Choice.
- Don Hempel family is looking for ideas for the memorial money. Ideas given were for the courtyard expenses, secretary's office cabinets and desk, benches for the courtyard, or funding for the west entrance and Anne mentioned it could be also unrestricted. Pastor will relay this information to Shirley.
- 125th Anniversary planning (100th was July 1999). Speaker needs to be contacted early, also a possible pictorial directory. Members for the committee so far are Sue Erickson, LuAnn O., Judy Rode, Pastor Varns, and also Joyce Cruser is interested.
- Paper Shredder truck planned for Sept 9 from 9-12. Thrivent is covering the \$1,000 fee for it. We're planning
  for an hour just for St. Paul members and then opening it to the public. They won't come weekdays; only Saturdays from 9-12. Phyllis, Jayne, Kathy E., Mary H., and LuAnn volunteered to be on a committee to
  go through the safe and see what should be kept or shredded.

This freedom moves them to desire faithfulness to Him. Faithfulness results in works. This is why James goes on the say: "What good is it, my brothers, if someone says he has faith but does not have works? Can that faith save him? If a brother or sister is poorly clothed and lacking in daily food, and one of you says to them, 'Go in peace, be warmed and filled,' without giving them the things needed for the body, what good is that? So also faith by itself, if it does not have works, is dead." (James 2:14-18)

James' point here is that saying you have faith is not the same as a faith that compels you to love and service. So it's not about just saying you have faith. It's about "doing" your faith also. But not for salvation. "Doing" instead as a result of your faith. Luther catches onto this when he says: "God does not need your good works. Your neighbor does."

So back to the original question: Do you have to go to church to be a Christian? How about this instead: genuine faith moves a Christian to desire to be in worship with his Lord.
